## **GENERAL:**

- 1. Pre-bid Conference Sign-In Sheet
- 2. Contractor Questions:
  - A. Question #1: Who is the existing fire alarm manufacturer/contractor for coordination of the new installs? The plans call out that the new devices must tie to the existing system.
    - 1. Answer: Per specifications, the fire alarm must be completed by a Notifier panel certified installer. These installer can be found on the website.
  - B. Who is the existing access control manufacturer/contractor for coordination of the new installs? The plans call out that the new devices must tie to the existing system.
    - 1. Answer: Per specifications, access control must be completed by a Vanderbuilt certified installer. These installers can be found on the Vanderbuilt website.
  - C. The bid form, section 6.b states a blank \$\_\_\_\_\_ for liquidated damages. What is the amount for liquidated damages? \$500.00
  - D. Will all five areas need to start construction at the same time?
    - 1. Answer: Contractor to coordinate with district on when the projects will start to achieve substantial completion as close as possible to the start of school.
  - E. Will Test and Balance be required?
    - 1. Answer: Test and balance will be required.



- F. Mountain View Middle School entry vestibule CMU wall: Are there engineering/architectural as-builts that show if the wall is load bearing?
  - 1. Answer: Existing drawings will be made available to the successful bidder.
- G. Rio Rancho Middle School Drawings: The scope of work includes demolition and capping of some existing plumbing and no new plumbing to be added, correct?
  - 1. Answer: This is correct.
